SUBJECT: 2023 Child and Adult Care (CACFP) Application Submission Deadline Reminder-1 day Remaining

Friendly reminder, the CACFP Applications must be completed and submitted prior to September 30, 2022, by 5:00 pm. All applications will be time and date stamped electronically upon submission. Any application submitted after the deadline will not be accepted and could be denied or ineligible to claim for October. If you choose to submit your application at the last minute, you will run the risk of not having your application processed in a timely manner.

Please ensure your application has been completed in its entirety and including the following: Online modules, uploaded documents, CACFP or CACFP At-Risk Annual Training for 2022-2023. The CACFP check list can be found in the SNP Resource Library.

Do not forget to log into the SNP system and check the status of your application. <u>Approved/Amended</u> means you have completed the application process and you are ready to begin your 2023 Child and Adult Care Food Program. If your status shows <u>Pending Approval</u> means you need to contact your Application Coordinator to see if additional information is needed for your application. <u>Pending Submission</u> means your application has not yet been submitted and has not been received by your Application Coordinator.

<u>Best Practice:</u> Schedule an appointment with your Application Coordinator to review your application and ensure that your application has been completed with accuracy and in a timely manner before submitting the application for approval. We look forward to a successful CACFP new year!
