## MEMORANDUM

SUBJECT: Tier 1 and Tier 2 Rate Claims for CACFP Day Care Homes

This is an important notification regarding the COVID-19 Child Nutrition Response #93 Nationwide Waiver of Area Eligibility for Family Day Care Homes (FDCH) for the 2022-2023 School Year.

Beginning July 1, 2022, and ending June 30, 2023, the Food Nutrition Service (FNS) waived for all states the area eligibility requirements for Tier 2 to allow CACFP Day Care Home Sponsors to claim meals and snacks (served to enrolled children) at the higher Tier 1 reimbursement rate.

CACFP Day Care Home Sponsors must log into their application, "CACFP Provider Agreement FDCH1" and switch to the correct Tier in preparation for the June 30, 2023, waiver end date. **This modification must be completed AFTER the claim for June 2022 has been submitted.** Failure to make the correct adjustment will result in an incorrect Tier rate claim reimbursement.

*A day care home that is located in a geographic area, as defined by FNS based on census data, in which at least 50 percent of the children residing in the area are members of households which meet the income standards for free or reduced - price meals is a Tier I day care home. All others are Tier II.*
