SUBJECT: 2024 SFSP APPLICATION FOR ALL ELIGIBLE INSTITUTIONS

We are extremely excited about the new 2024 year! On January 14, 2024, applications for the 2024 Summer Food Service Program (SFSP) are now open to all qualifying institutions.

Please log into the SNP system and check the status of your application. If the status states "Approved/Amended," you have completed the SFSP application process and you are ready to begin your 2024 Summer Food Program when school is officially not in session for Summer. If the status states "Pending Approval," you must immediately contact your Application Coordinator to complete your application. If the status states "Pending Submission," this means your application has not been submitted and therefore it has not been reviewed by the Application Coordinator.

All online modules and program trainings must be completed prior to the application submission, and all required documents must be uploaded into the SNP system. It is best practice to have your training attendance date close to your submission date to avoid a denial of your application. If you plan to utilize the Commodities Program, you must notify your Application Coordinator immediately.

Once your application has been completed in its entirety and submitted for review, within 30 days you shall receive an approval or denial determination. Failure to complete and submit your application within 30 days from the open day of recertification will result in a denial determination. If you have questions or concerns regarding this MEMO, please do not hesitate to contact your Application Coordinator.

Important Dates:

- ❑ SFSP Schools Only Applications open to all eligible institutions January 14, 2024.
- ❑ SFSP Applications open to all eligible institutions February 14, 2024.
- ❑ SFSP Application soft deadline for your submitting the application is March 31, 2024
- ❑ Request for Commodities must have a final approval for their application by April 30, 2024.
- ❑ Deadline for all applications to be submitted is April 30, 2024, by the end of the day. (11:59 p.m.)

TIP: Do not submit your application until you have met your application coordinator. This way we can save time and effort in ensuring that your application is complete and ready to be reviewed.
