FY 2023 Farm to School Grants

The Richard B. Russell National School Lunch Act (NSLA) (**42 USC 1751** et seq.) establishes a Farm to School Program in order to assist eligible entities, through grants and technical assistance, in implementing farm to school programs that improve access to local foods in the USDA Food and Nutrition (FNS) Child Nutrition Programs, including the National School Lunch Program (NSLP), School Breakfast Program (SBP), Child and Adult Care Food Program (CACFP), and Summer Food Service Program (SFSP).

The 2023 Farm to School Grant deadline is January 6, 2023

Healthy Meals Incentives

USDA's Food and Nutrition Service (FNS) has established the Healthy Meals Incentives Initiative to improve the nutritional quality of school meals through food systems transformation, school food authority recognition and technical assistance, the generation and sharing of innovative ideas and tested practices, and grants.

Healthy Meals Incentives also offer sub-grants entitled Healthy Meals Incentives School Food System Transformation Challenge Sub-Grants. Full grant applications are due via <u>Grants.gov</u> by 11:59 pm ET Feb. 1, 2023. Applications received after the deadline are deemed ineligible and will not be reviewed or considered. CACFP Program Review Tips

Here are some ideas to help easily and permanently correct the most common Compliance Review Findings:

- **TIP #1:** Have a system in place that ensures staff records meals at the time of service.
- **TIP #2:** Automate your enrollment and income forms. Use software that allows you to send forms to parents electronically and updates your system in real time, including categorizing parent's income/classifying the child.
- **TIP #3:** Actively monitor your program expenses to ensure they equal or exceed your monthly reimbursement. You may need to amend your contract budget as well.
- **TIP #4:** Utilize CACFP software for organizing and documenting milk purchases.
- **TIP #5:** Time Distribution reports can be automated to ensure they are completed each month.

Applications

January 14, 2023 – Schools open enrollment to submit applications for the 2023 Summer Food Service Program (SFSP)

February 14, 2023 – Open enrollment for all institutions begin for the 2023 Summer Food Service Program (SFSP)

April 30, 2023 – The deadline date for all applications to be submitted for approval

April 30, 2023 – The deadline date to request commodities for SFSP 2023 (the application must be approved by April 30, 2023, to receive commodities).

Tips for Applications:

- 1. Contact your Application Coordinator (AC) to set an appointment to start the process.
- 2. Know where you want to establish a site(s) and get the site agreement completed.
- 3. Know your budget, i.e., your expenses, salaries, food cost, food supplies, and all other possible expenses.
- 4. Be proactive in the application process and do not wait until the last minute.
- 5.A Successful SFSP year requires both the State Agency and the Sponsor working together throughout the entire process.
