# Fiscal Year 2022 CACFP & SFSP Area Eligibility Data Now Available

The USDA Food and Nutrition Service (FNS) is excited to announce that the 2022 Child and Adult Care Food Program (CACFP) and Summer Food Service Program (SFSP) participant Area Eligibility data are now available. At the start of every fiscal year, FNS releases a special tabulation of data provided by the Census Bureau for CACFP and SFSP that establishes area eligibility in the CACFP and SFSP. These data are effective as of October 1, 2021. The FNS mapping tools have also been updated to reflect the new data. To see the map, click this LINK. 
**Commodity Distribution**

His Unit is also responsible for the distribution of food for congregate feeding during disasters and for those in shelters. During State Fiscal Year 2021, the Commodity Distribution Unit distributed over \$43 million in food to serve the children. families, and seniors of the State of Arkansas. To support a successful school reopening in school year 2021-22, and to promote afterschool and child care, FNS is releasing a new suite of waivers and flexibilities to increase funding, support access, and balance operational needs with the goal of providing nutritious meals:

- <u>Nationwide Waiver to Allow Summer Food Service Program Reimbursement Rates</u> FNS is allowing school food authorities to claims NSLP SSO meals and snacks at the SFSP reimbursement rates.
- <u>Nationwide Waiver of Meal Times Requirements</u> FNS is letting meals be served to kids outside traditional times to maximize flexibility for meal pick-up.
- <u>Nationwide Waiver to Allow Parents and Guardians to Pick Up Meals for Children</u> FNS is allowing parents/guardians to pick-up meals and bring them home to their children.
- Nationwide Waiver to Allow Specific Meal Pattern Flexibility in the Child and Adult Care Food Program FNS is giving states the flexibility to serve meals that do not meet specified meal pattern requirements when needed.

## **CACFP** Reimbursement of Breast Milk or Formula

Did you know that as an early childhood center or home caregiver you may receive reimbursement when serving an infant breast milk, infant formula, or a combination of both?

A A

To receive reimbursement, the center or home caregiver must serve and feed the infant a developmentally appropriate meal. The following are eligible for reimbursement:

- If a parent provides expressed or pumped breast milk, the meal is reimbursable. A baby zero to 5 months of age may be fed solely breast milk as breakfast, lunch, and a snack. As long as the baby is offered the minimum amount of breast milk required by the CACFP, you can claim it as part of a reimbursable meal even if the baby does not drink all of it. The minimum amount of breast milk for babies zero to 5 months at breakfast, lunch, supper, and snack is 4–6 fluid ounces. The minimum amount of breast milk for babies 6 through 11 months is 6–8 fluid ounces at breakfast, lunch, and supper, and 2–4 fluid ounces at snack (along with other required meal components). Some babies may regularly drink less than the minimum amount of breast milk required. In this case, you may offer less than the minimum amount of breast milk at each feeding as long as more breast milk is offered later when the baby is hungry. This should be documented on infant daily sheet and/or production record.
- Giving a baby both breast milk and infant formula in the same meal or snack is creditable in the CACFP. Be sure to feed the baby the breast milk first, and then the infant formula. Babies should be fed the minimum requirement according to the age and meal pattern.
- You may claim reimbursement of meals when a parent breastfeeds at your child care site.
   This includes meals when the baby is only drinking breast milk. Parents do not need to provide a written request for the meal to be reimbursed. If a parent breastfeeds at your child care site, you may claim that milk as part of a reimbursable meal as long as you provide all other required food components.
- For children age one year and older, breast milk can be used to meet the CACFP fluid milk component of a meal. As a CACFP provider, you will still receive reimbursement for meals and snacks when a child receives breast milk after one year of age. A written request from the parent is not required.

#### **Grant Opportunity**


